Information Gathering Policy

**The following is a definition of Cookies, as used in the section "Advertisement and Cookies*" above.*

Invented in 1994 by a 20-year old programmer named Lou Montulli, a cookie is a small data file that certain websites write to your hard drive when you visit them. A cookie is a simple piece of text. It is not a Program or a plug-in. It cannot be used as a virus, and it cannot access your hard drive or read cookie files created by other sites. A cookie file can contain information such as a user ID that the website uses to track the pages you visit, but the only personal information a cookie can contain is information which you supply yourself.

Visitors to any website (other than this one) should be aware that two general levels about their visit can be retained. The first level comprises technical information – about all visitors – collected on an aggregate basis, and the second is information about a specific visitor who knowingly chooses to provide that information.

The statistical information provides the website manager with general (not individually specific) information about the number of people who visit his or her website, the number of people who return to the site, the pages that they visit, where they were before they came to the current web page, and the last page they saw before they exited. The website manager may also collect certain information such as the type of browser being used (e.g.,

Chrome, Internet Explorer, Firefox, Opera, Safari), the type of operating system being used (e.g., Windows or Mac), and the domain name of your internet service provider (e.g., Xfinity, Verizon FIOS, America Online).

The information helps well-informed website managers to monitor traffic on his or her website in order to analyze usage and manage the sites content and capacity. It also shows which parts of the website are most popular, and generally to access user behavior and characteristics in order to measure interest in and use of the various areas of the site. This helps facilitate improvements in the design and content of the website and enables the manager to personalize your internet experience.
